## OREO® LIFT OFF SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER. MAKING A PURCHASE WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The OREO® Lift Off Sweepstakes ("Sweepstakes") is sponsored by Mondelēz Global LLC ("Sponsor"), 100 Deforest Avenue, East Hanover, NJ 07936 and is administered by Twelve Thirty, LLC ("Administrator").

- 1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins at or about 12:00 AM (midnight) Eastern Time ("ET") on January 29, 2024, and ends at 11:59:59 PM ET on February 29, 2024 ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes's official clock.
- 2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees, officers and directors of Sponsor, Administrator, HMT Associates, Inc., and any of their respective owners, parent companies, affiliates, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the "Sweepstakes Entities") as well as the immediate family members (defined as including spouse; biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. Void where prohibited by law. All federal, state and local laws apply.

Participation constitutes entrant's (and entrant's parent's or legal guardian's if entrant is deemed a minor in the jurisdiction in which entrant resides ["Minor"]) full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. If it is discovered or suspected that an entrant has registered or attempted to register for the Sweepstakes more than once per calendar day using multiple e-mail addresses, multiple identities or any other methods, all of that entrant's entries will be declared null and void and any prize that he/she might have been entitled to win will not be awarded and will be revoked. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any entrant attempting such use.

3. HOW TO ENTER: During the Sweepstakes Period, eligible entrants must visit http://oreospacecamp.com/ ("Website") and submit their valid e-mail address. If it is the entrant's first time participating in the Sweepstakes, the entrant must first complete and submit the registration form with all required information, which may include, but may not be limited to, first and complete last name (no initials), telephone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, and date of birth. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes.

**LIMIT:** Each entrant is limited to receiving one (1) entry per day during the Sweepstakes Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a

calendar day during the Sweepstakes Period. If more than one (1) entry per day is received from the same person, telephone number, address, or e-mail address, and no attempted fraud is suspected, only the first entry received may be considered valid. If fraud is suspected by the Sponsor or Administrator, the entrant will be disqualified and all of his/her entries will be declared null and void.

**4. RANDOM DRAWING:** On or about March 1, 2024, the Administrator will randomly select two (2) potential winners from all eligible entries received during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

## 5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

a. <u>Prizes</u>: Two (2) prizes (each, a "Prize") are available to be won in the Sweepstakes:

One (1) Space Camp Prize: A trip for four (4) (winner and three (3) guests)\* to participate in a three (3) day Space Camp at the United States Space & Rocket Center in Huntsville, AL, on a date to be determined by Sponsor (tentatively scheduled between September 2024 and September 2025). If any of the selected winner's guests do not meet these age requirements, as set forth by the United States Space & Rocket Center, Sponsor will award all remaining elements of the Prize.

One (1) Florida Prize: A trip for four (4) (winner and three (3) guests) to the east coast of Florida.. Prize package includes round-trip coach class air transportation from a major commercial airport near winner's residence (determined by the Sponsor in its sole discretion) to Orlando, Florida for winner and up to three (3) guests, three (3) nights standard hotel accommodations (one [1] room, quad occupancy), round-trip ground transportation between hotel and airport; four (4) space experience passes; gift bag; and \$1,980 in spending money via a check made payable to the winner that may be used for any purpose winner chooses. Should any event, element or detail of a Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the Prize, minus any unavailable event, element or detail. Winners agree that all location admissions are awarded pursuant to a revocable, nontransferable license that is personal to that applicable winner, and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. - b. Total ARV: The total ARV of all Prizes available in the Sweepstakes is \$17,680.

- **d. General Prize Conditions:** If, due to human or other error, more than two (2) Prize notifications are issued, the Sponsor will select the intended two (2) winners in a random drawing from among all recipients of such notifications.

Upon verification of eligibility, Sponsor's designee will contact each winner to arrange travel booking.

Sponsor will issue an IRS Form 1099-MISC to each winner for the value of their Prize. Sponsor will attempt to notify the potential winners as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification email, to a spam or junk folder.
